

From Property Professional to Property Investor: My Journey into Entrepreneurship

In 2014, I decided to take a break from my career and travel to explore different opportunities. During this time, I read extensively on self-development, which marked the beginning of my transition from a property professional to a property investor. After realizing that working for someone else was no longer in line with my goals, I established my own property consultancy in 2016. I began investing in apartments on a Rent to Rent basis in Nottingham and ran them as Serviced Accommodation. Additionally, I founded Progressive Property Network – a monthly networking event in Birmingham – to build a strong investor community and facilitate collaboration.



Building a Commercial Property Investment Portfolio While Giving Back My top priority right now is to build my commercial property investment portfolio with my business partner in Wem Commercial brand. We have one brand focused on commercial investment and the other on commercial developments. Our current portfolio is valued at £1.4m with a rental income of £130,000 pa, which will rise with asset management opportunities.

Recently, I moved my pensions to a SIPP and began investing jointly with other SIPP investors in commercial development projects. In addition, I am currently mentoring a few private investors, sharing my 20 years of experience and offering focused guidance on investing in commercial property. This includes finding opportunities and building a portfolio.

Alongside this, I still provide consultation services to property developers and funds on an ad hoc basis. My role involves asset managing commercial properties to increase their value and disposing of surplus stock.



Ultimately, my goal is to create my own band to fund commercial property investments while pursuing my true passion of helping others through charitable causes and urban regeneration projects.
